# HOW DO YOU DESCRIBE HOPE?

Is it a feeling? A sense? A tangible thing?

Webster defines it as an expectation of fulfillment or success; to want something to happen or be true.

Since 2000, hundreds of people began describing hope as 'Betterment.'

Not just a feeling, not just a wish, but a group of people who believe in the power of changing lives with one simple gesture of kindness. A group that gave them the gift of a helping hand when they needed it most. A group that sees in those they assist a promise of a better world. Because, even in a time of great need, those recipients they help continue to serve others.

This is our story of hope. Our story of the Foundation for Community Betterment. For 20 years, we have learned the meaning of hope through the eyes and hearts of the 400 recipients we have served, and through the hands and hearts of all the volunteers and donors who have served them.

Whether a donor, volunteer, board member, or recipient, we all have been touched by Betterment's ripple of kindness, and have experienced the power of that wave of hope as it has changed lives.

# OUR HISTORY OF HOPE

In April of 2000, then 29-year-old Brendan Curley, shared a story of a young man named Justin with seven of his peers: Jennifer Curley Reichert, Shannon Curley Tower, Jody Graham, Erin Greenlee, Steve Pinkos, and Alex and Andy Rodman.

Brendan met Justin through mutual friends in Virginia Beach, VA. They would see each other periodically as they both loved sports and participated in the Muscular Dystrophy Association (MDA) summer camps and fund-raisers. Justin had been suffering with MD for several years and was confined to a wheel chair. Brendan was immediately drawn to his strength, sense of humor, and fighting spirit in facing his illness.

As time progressed, Justin told Brendan that he needed a new wheelchair, and insurance wasn't going to cover the type of chair he needed. The money they were working together to raise for MDA would go into a large national research fund, that although very important, would never touch Justin personally.



## OUR ORIGINAL TEAM OF EIGHT WAS INSPIRED.

We not only wanted to help Justin, but we realized that there are thousands of Justins in our communities. And, that through our personal networks, we could not only find those in need, but join together to help them.

#### WE WERE ENERGIZED.

We gathered by conference call, and the energy of eight dynamic individuals across the country funneled into Betterment's mission statement and our three recipientfunding criteria:

AN IMMEDIATE IMPACT – Because of Justin and his pressing need for a new wheelchair, Betterment helps individuals and organizations like him who have immediate and tangible needs.

A NETWORK CONNECTION – Because we want to fund a varied group of individuals and organizations, we want to ensure thour recipients have touched someone in our network. It is our way of encouraging all of our volunteers, donors, friends, and family to reach out and make a difference in the lives of people in their communities.

A GIFT THAT KEEPS ON GIVING – Justin's volunteerism, even at his time of need, really made an impact on our Betterment group. By assisting someone as philanthropic as Justin, we help them continue their good work in the community. A true ripple effect in action.

## WE WERE UNIFIED.

With our mission and our recipient criteria in place, we planned our first golf tournament in Washington, D.C. for August of 2000. That event focused on one recipient, Anthony Ginnetti. Even though only one person at the 100-person event knew that recipient, the energy was palpable and it ignited Betterment's wave of goodness that continues to spread throughout communities today!



# SPREADING THE RIPPLE EFFECT OF GOODNESS

Since that first event, thousands of people of all ages have shared tremendous Betterment moments together with one simple goal – spreading the ripple effect by helping others.

As more people experienced the power of Betterment's mission and the energy of those who gathered, more events were created in Charlotte, Alexandria Bay (NY), Cleveland and Buffalo. In less than 10 years, we grew from our original national board of eight people, to a national board of 16 and nine chapters with individual boards in each of those cities.

As we grew, Betterment took a unique shape in each community based on how the volunteers determined they could best serve those in need. These amazing chapters and volunteers are the reasons Betterment still thrives today. They continually share their generous gifts of time, expertise and energy to spread the Betterment ripple effect of goodness across the nation.



# CHAPTERS CHANGING LIVES





As the original host community for Betterment's national events, the WASHINGTON, D.C./ANNAPOLIS team of volunteers has been active since the beginning. D.C. has played host to 17 golf outings, casino nights and cocktail gatherings that have raised funds to support 27 recipients in D.C. and beyond.

Just next door, the ANNAPOLIS team was ignited in 2015 and has been a part of numerous community events, as well as hosting their annual signature event, Betterment Bash.





In 2001, ALEXANDRIA BAY hosted its first Paddle for Betterment kayak event expanding Betterment's reach to Upstate New York. Since its first event, the Alex Bay team has hosted 19 Paddles and expanded the weekend event to include both a tennis match and golf tournament, as well as a kids bike-a-thon organized by children in the community. The Alex Bay chapter has donated to over 70 recipients and has started an endowment fund to ensure the chapter continues to help those in need in the Thousand Islands for years to come.



# CHAPTERS CHANGING LIVES CONTINUED





CLEVELAND rocked the Betterment ripple as the first official chapter formed in 2005. Their annual event grew from flappers to movie stars to their Black & White Ball, and for 13 years they raised more than \$500,000 for 57 recipients.

BettermentBash has become a signature event in the CANTON, OHIO community and its success has provided more than \$189,000 to 50 deserving recipients in the Canton area. From Boo Bash to Rocktoberfest to the Roaring '20s, Canton's themed events continue to draw a bigger crowd each year. Since 2007, when the Canton Chapter was formed, their volunteers have created opportunities for outreach at food banks, domestic violence shelters and other local nonprofits. Their philanthropic spirit has also spread to the younger generation who formed Betterment's first junior board, JBB (Junior Betterment Board) in 2017.

# I M M E D I A T E A N D I M P A C T F U L

As our network began to grow, so did the number of recipients who came to us with very immediate needs. In some cases, their needs so pressing that there wasn't time to plan an event. To address this, Betterment established our IMMEDIATE NEED FUND (INF) in 2002 to enable us to act quickly in sharing support when time is of the essence.

Since its inception, the INF has enabled Betterment to share more than \$100,000 with 50 recipients with gifts ranging from \$250–\$5,000.

Our INF was just one of the many ways we adapted to the needs of our recipients and volunteers. Long before 'Go Fund Me' existed, many in our network came to Betterment for help in creating and managing email blasts, special donation webpages and fundraisers for their friends and family in need.

2008 recipient Julien Henley was the perfect example of our agility in response to needs. Julien's friend and Betterment supporter, Anthea Knapp Turner immediately turned to Betterment when Julien was accidentally shot and paralyzed. Anthea had Julien's network of friends, but she needed Betterment to provide the e-infrastructure to reach Julien's supporters and organize their gifts. Together, we raised more than \$13,000 from 35 individuals across the country in just a few days to help with Julien's extensive bills so he could focus on getting stronger.

The friends of Chicagoan Matt Isenberg are another great example of responding to the needs of our supporters. In 2009, Matt's friend and Betterment donor, Matt Cushing approached Betterment because Isenberg had suffered a brain hemorrhage and his friends wanted to help the young father. The Chicago Chapter worked with the Isenberg's team of friends and family, and together raised more than \$200,000 to help the Isenbergs, and other Immediate Need Fund recipients. These funds helped the family begin to start the long journey towards Matt's recovery.

# INVESTING IN OUR GROWTH

This adaptation and growth of our national office efforts required an investment in our infrastructure. In the early years of the Foundation, Betterment utilized the help of wonderful recent college graduates to manage our website, database and donation acknowledgments. The time had come to invest in hiring a foundation manager who could help us better serve the needs of our volunteers across the country so that many more recipients could be helped.

In 2009, Betterment asked for the support of our closest friends and donors to create our FOUNDERS' CIRCLE. Twenty-three individuals said 'Yes' to sharing a \$1,000 tax deductible gift a year for five years.

Their generous 'yes' enabled Betterment to hire our first full-time staff person to support our community-led chapters. It also allowed us to expand our website and database to better support and empower the hundreds of volunteers across the country. And, the Founders' Circle gifts also allowed us to secure our INF so that our recipients with the most immediate needs can always be helped.

# INVESTING IN OUR GROWTH

In 2010, we expanded on this generous circle by creating the FRIENDS OF BETTERMENT to recognize those who also invested in our mission with gifts of \$200 a year for five years. This additional support of our overall foundation efforts truly launched our growth for the next 10 years.

Overall, there have been 41 Founders Circle members and 31 Friends of Betterment and together, they have shared more than \$290,800 to support our general foundation efforts and our INF recipients.



#### ENCOURAGING YOUNG PHILANTHROPISTS

Since our inception, people of all ages have been involved in making Betterment events a success. Being an example for the younger generation and providing opportunities for them to get involved are some of the most powerful ways to strengthen communities.

From raffle ticket sales to their own personal donations, children in our network have jumped in to lend a hand and shared their hearts with our recipients.

In 2011, Betterment partnered with long-time supporter and author PAUL REICHERT to further teach generosity to children through his children's book *The Lemonade Ripple*. Paul wrote and illustrated The Lemonade Ripple based on the Betterment ripple effect, and it has inspired hundreds of little helping hands in communities and schools where it has been introduced. The book launched with lemonade stands all over the country and continues to be an inspiration for young philanthropists to make a difference in their communities.

In Alexandria Bay, the next generation of philanthropists started a Bike for Betterment, raising over \$2000 in 3 years!

In 2017, our Canton Chapter launched the first-ever Junior Betterment Board to empower the next generation to get involved in understanding the importance of helping others.

## POWERFUL PARTNERSHIPS

Throughout our history, Betterment has also seen tremendous growth by partnering with other likeminded groups. By offering event logistics and infrastructure assistance, we have helped fellow charities fundraise to expand their reach. Though we have highlighted just a few, we are grateful to all of the charity groups who have partnered with us, enabling all of our organizations to make a greater impact on the recipients we serve.



#### WHITE HOUSE GOLFERS

Betterment has always loved getting on the golf course for a good cause. So, when 2007 recipients Linda and Mike Finnerty introduced Betterment to the White House Golf Association in Washington DC, we were excited to partner. Mike had been active in the group who was looking for a charity partner. Given our support of the Finnertys and our mission, Betterment was the natural choice for them. In 2011, our national office created and managed the online event registration for their annual golf outing so that their group was able to focus on recruiting players and showing them a fun time to benefit those in need. Funds raised from this partnership supported our Immediate Need Fund and together we raised \$30,000 for INF recipients.

#### ZOONEYFEST, BINGHAMPTON, NY

Zooneyfest started in 2005 as a benefit for Joe Zunic who was diagnosed with ALS. Joe was an active participant in the game of life and was always a person to help other people out. Joe initially resisted the idea of a benefit in his honor, but he agreed to it on the condition Zooneyfest continue as a vehicle to help others facing similar circumstances. Zooneyfest joined Betterment in 2013 to leverage our national network and expand its role in their community. Together, with support from our national office, Zooneyfest was able to help 20 different recipients in its 10 years of events. It also brought Betterment new board members at the national level and a new chapter city.



#### THE GO BO FUND, WASHINGTON DC

When he was in the sixth grade, Bo Johns battled cancer which required him to spend 87 days at Georgetown University Hospital. During his time there, Bo and his parents Ben and Deb saw many other patients who could use extra assistance in order to help them through treatment. With that need in mind and through the generous support of the family's community, he and his family created The GO BO Fund. Through donations and 15 annual fundraisers, the GO BO Party, the Fund has provided over \$750,000 in financial support to children and families battling cancer and other blood diseases. GO BO, through Georgetown University Hospital's Department of Pediatric Hematology and Oncology Emergency Family Relief

Fund, provides immediate and critical support for needs such as transportation, lodging, and utility payments. The family wanted to expand their efforts and was introduced to Betterment through our National Board Members, Jared Bowling and Julie Chamberlain. GO BO joined forces with Betterment in 2015 and together have helped to expand the event and impact for patients at Georgetown University Hospital. The Johns are now Founders' Circle members and Bo serves on Betterment's national board to help grow our other efforts as he and his family have grown GO BO.

# SPECIAL HELPING HANDS





Over the years, Betterment has been blessed with thousands of tremendous volunteers and donors. There aren't enough pages to recognize all those whose generous hands have shaped Betterment, but we've highlighted a few here that best represent the unique and giving spirit of all who join in our mission. We are so grateful for each donor and volunteer recognized in this book for their special partnerships with us, and for all those who have stepped up to make the ripple effect continue.

THE CHAMBERLAIN FAMILY is one of those special partners. Since our inception, Robert and Patricia, and their children Julie and Rob have attended Betterment events, rallied support from others and donated to Betterment. Julie became an active national board member in 2010 and has been instrumental in growing our Washington D.C. Chapter.

The Chamberlain's also introduced Betterment to our first international recipient, Kiyas Nasrudeen, who we helped after his village was ravished by a tsunami in 2005 (pictured on left).

In 2010, the Chamberlains created a fabulous opportunity for Betterment to expand our reach and encourage others to support our foundation in a fun way. With the generous gift of a 2-week stay at their time-share condo, Betterment created our NATIONAL RAFFLE giving our network the chance to win a free condo for a week anywhere in the world! And, the second week is used every year at the chapter level to give our chapters the chance to offer it as an auction item or raffle to raise money for their recipients.

We are so thankful for the Chamberlain's unique and continued support that has helped us raise an additional \$6,500 every year in our National Raffle.

Just a few years prior to Betterment's first golf outing in D.C., Chicago entrepreneurs DAVID HALPERN AND BEN KLOPP launched their first entertainment venue, aliveOne in Chicago's Lincoln Park. When Betterment founders shared their desire to launch our philanthropic initiative, David and Ben didn't hesitate to provide their support.

Though their business was based in Chicago, they still were one of our first donors to sponsor a hole at our inaugural Betterment golf outing in D.C. Like Betterment, their business grew and developed by adding partners BOB DECK and Dan Cronican to create FOUR ENTERTAINMENT GROUP (4EG).

4EG was critical in helping launch the Chicago Chapter by playing host to all meetings and events at aliveOne Bar and Estelle's. They also provided support to our growing Cleveland chapter, and most recently have been instrumental in supporting our newest chapter in Cincinnati where they have hosted our Mardi Gras Happy Hour and our Haunted Hustle. We are so grateful for 4EG's partnership in helping us grow as they have.

# SPECIAL HELPING HANDS



In 2016, during our annual D.C. golf tournament, longtime Betterment supporter TIM SULLIVAN learned that our event recipients, The Kolb Family, were enduring a leaky roof in addition to fighting a cancer battle. Tim (pictured top left) immediately offered to fix their roof free of charge by the skilled tradesmen at his company CAPITOL HILL CONSTRUCTION. That extremely kind gesture allowed us to use event proceeds to help an additional recipient: a neighboring family of the Kolb's who lost a husband and father of three to a sudden heart attack. Since then, Tim has joined the national board and has been invaluable in garnering support for our yearly DC golf tournament. We are thankful for Tim's generosity as well as his gift of always giving his warm heart to Betterment.

SANDY CROUCHER started out like any other Cleveland Chapter volunteer; focusing on a specific portion of planning an event - food, decorations, music, etc. It became very apparent early on that Sandy was destined for a bigger role. Whenever the committee needed special attention payed to a detail, Sandy always stepped up; not only by lending a hand, but by providing strategy and guidance. When the Cleveland's Black & White Ball Chair position became vacant in 2010, there was really no other choice. Sandy (pictured bottom left) was clearly the person BettermentCLE wanted and needed to fill the role. For several years and events, Sandy led with a passion for the mission and a true love for the recipients. She proved an invaluable asset to BettermentCLE's success and we can't thank her enough!

When KARA WEDEKAMM of Canton, Ohio and her friend (and Betterment Board Member) Amy Weisbrod talked about sharing their time and talents in their community, Amy suggested Kara should join a meeting of the newly formed Canton Chapter. That first meeting turned into more than ten years of Kara pouring her heart, organizational skills and talent into changing lives and improving our community. From using her skills in graphic design and event planning to always be willing to raise her hand, Kara (pictured left) has been a difference-maker in Canton. The Canton Chapter has grown in large part because of her constant willingness to help with anything that is needed, but most of all because of her unwavering spirit. Her legacy is that we are all challenged to forever to live up to her example.


**RECIPIENT IN 2000** 

Anthony was just 31 years old when he was diagnosed with cancer. As a construction professional who had to stop working, the costs of his experimental treatments soon became overwhelming for he and his young wife, Sue. Even through their toughest times, Sue and Anthony still managed to bring joy to others by working and serving the children of the cancer ward where Anthony was treated.

Theirs was a story that truly epitomized what Betterment's original founders envisioned in a recipient. People who, even when faced with difficult times themselves, still manage to help others. They were the perfect first recipient. With the help of over 100 guests at our inaugural D.C. golf outing in August of 2000, Betterment raised enough funds to pay for the Ginnetti's mortgage for one year.

Sadly, not long after the golf outing in their honor, Anthony passed away. Thankfully, Sue was able to remain in their home and stay involved in their community. She later remarried and feels blessed to have raised two beautiful daughters in Chagrin Falls.

Helping Others Prepare for Employment was a program designed to train Charlotte's chronically unemployed individuals with carpentry skills – a much-needed trade in the community as the construction industry grew. Betterment's Charlotte volunteer team, led by one of our founders, Erin Greenlee, wanted to help Project H.O.P. E. because this unique organization gave those in need the skills and confidence to better themselves and their communities.

The Charlotte team created a St. Patrick's Day weekend celebration with golf, boat rides and parties that enabled Betterment to fund the tools and equipment each participant would need to learn their new trade. According to Project H.O.P.E. founder, Betterment's investment helped to build the workforce for the Charlotte community, but more importantly build confidence for people who need it most.

#### MARC MILKIE &

#### THE MILKIE FAMILY

CLEVELAND, OH

**RECIPIENT IN 2002** 

The waves of the Milkie ripple effect have reached far beyond where we ever imagined when we first met Marc and his brother Dana in the early years of the Foundation.

At age 39, Marc was training for his 4th marathon when he went into the hospital with breathing problems. He left the hospital eight months later as a dual amputee. The devastating effects of the rare disease, Granulomatosis with Polyangiitis (GPA), ravished his body, but not his spirit and his drive to serve others.

When the Betterment Board first learned of Marc's story, we knew we wanted to help. More than 120 guests joined together at our 3rd annual D.C. golf outing to raise funds for Marc, his wife and four young children. However, Marc didn't want to accept our financial help until he was rehabilitated enough to truly give back to his community. After months of successful rehab, he used Betterment's support to equip his vehicle with hand controls and to take a special driver training course so that he could stay active in his community as a coach and volunteer.

Marc's involvement in his community wasn't the only way his ripple effect spread. In 2003, he inspired hundreds as he drove the first ball off the tee of our 4th annual D.C. golf outing! With that inspiring swing, and by officially joining Betterment's national board in 2003, he propelled Betterment to new heights. Marc has been a tireless leader for the Cleveland chapter and our national board serving as vice president from 2014 – 2018. He has strengthened every chapter by participating in and promoting events throughout the country. By always engaging his friends and family in our Betterment mission, he continues to help us grow.

Marc's brother Dana, who initially introduced Marc to Betterment, has also made tremendous waves in our Betterment ripple. Dana started and grew a chapter in Seattle, helped build our Founders' Circle, worked tirelessly on various committees of our national board, and became the national board's 2nd president in 2014.

The Milkie brothers have been a powerful force in our Betterment ripple, and there is no one who embodies the spirit of Betterment more than the Milkie Family. Their impact will forever be felt in the lives of hundreds of recipients who have benefited from their influence.

#### RACHEL DOROCAK

STRONGSVILLE, OH

1ST CLEVELAND EVENT RECIPIENT IN 2004

At only seven months old, Rachel Dorocak became paralyzed from the effects of Transverse Myelitis (TM) due to spinal cord swelling following a respiratory infection. Initially, she was paralyzed from the neck down. After four years of extensive therapy, she gained use of her arms and hands and could ambulate short distances with long leg braces and cuffed crutches.

For her first birthday, her brothers – then ages 4 and 6 – started a program called Reading for Rachel. Through their creative endeavors, they encouraged their peers to get sponsors for reading books to raise money for TM research in Rachel's honor.

What Kevin and Matthew did for Rachel, and the 34,000 other Americans affected by TM, truly embodies the Betterment mission. That is why Rachel and her family were such worthy recipients for Cleveland's 1st Annual event in 2004.

Funds raised at the event helped the Dorocak's purchase a piece of Rachel's therapy equipment that is critical to her ability to walk but not covered under her family's insurance. This equipment also helped other children as the Dorocaks shared the equipment when Rachel progressed to the next level of therapy.

Today, Rachel is an active 20-year-old attending The Ohio State University and is on her way to a career as a pediatric occupational therapist. Together, with her brothers, they have raised a total of \$50,000 with the Reading for Rachel program!









#### JACKSON REBUILD PROJECT

JACKSON, MS

**IMMEDIATE NEED RECIPIENT IN 2005** 

In the last 20 years, the world has seen a number of devastating natural disasters. Unlike other large nonprofit relief agencies, Betterment created a unique approach to addressing the needs of those most affected by these tragedies by empowering others to help. In the aftereffects of natural disasters like the 2004 tsunami in Sri Lanka and Hurricane Katrina in 2005, Betterment rallied support for individuals who were driven to jump into the heart of the disaster and get their hands dirty in the process.

Louis Linsmeyer of Chicago, IL was one of those people when Hurricane Katrina hit the Gulf Coast in 2005. Louis rallied a group of young volunteers from Chicago who committed their personal time and money to help rebuild areas near Jackson, MS. Their dedicated team of nine rented a U-Haul truck over the holidays, loaded it with building materials (that they knew were in desperate need along the coast) and headed south to help a local church and residents rebuild.

Betterment donated \$2,600 from the Immediate Need Fund to pay for their truck and fuel costs, then created an online donation page and email blasts to help them raise over \$7,000 to purchase the needed tools and building supplies.

At a time when deploying dollars through large agencies had challenges, Betterment donors appreciated knowing exactly how their donation was used, and could truly see the impact their gifts made through the hands of the volunteers immediately putting it to use!

serve their community while in the stage of raising young children. According to Kate, "It has been a wonderful lesson for their own children to learn what it means to open their hearts and home, and unconditionally love others."

Beyond their outstanding community support, both Jeremy and Kate helped to spread Betterment's ripple of goodness in WPB. They spearheaded the creation of the Chapter's Play for a Purpose event to support families with children with disabilities. Together with the WPB volunteers, they raised \$2500 to support two young families.

The damage was so significant, that she is now in stage 4 renal failure, receives dialysis 4 times per week and is currently searching for a new living donor.

Before the accident, the Barr Family was involved in their schools and their community. After their recovery, they became even more committed.

Both girls now attend Cleveland State University. Sophia is involved with campus ministry as a volunteer with their Kids Club and Sierra plays on the CSU Quidditch team. Sophia also tutors children in grades K-3 and serves the less fortunate on Mondays at Malachi House. Tina and Sophia regularly volunteer for the Annie Dawson Foundation that shares scholarships for first year college students. Sophia earned one of their scholarships, so they always try to give back by helping them out at their events.

As a result, Jacob's family has staggering medical bills and stress. Our 2019 Canton Bash brought together 160 guests to help raise funds to cover mortgage and car payments so the family can focus on the rising medical needs.

Jacob's dad, Mike shared his gratitude for Betterments' support: "We cannot thank you and your team enough for all that you've done for us. This has been a year of feeling like we are constantly fighting a losing battle and it's can be incredibly difficult to keep going on with a positive attitude. Getting beaten down gets old and it makes it difficult to smile... What your gift has given us is the ability to get ahead of and plan for the steady stream of medical bills; basically, self-sufficiency.


